Speakers

Thenesh Kannaa is a partner at TraTax. He is a licensed tax agent for income tax, a member of the Malaysian Institute of Accountants ("MIA") and the International Fiscal Association (IFA, Netherlands), and a fellow member of the Association of Chartered Certified Accountants (FCCA, UK) and the Chartered Tax Institute of Malaysia ("CTIM").

Thenesh is the Chairman of CTIM's Technical Committee on Direct Taxes and a member of the Technical Committee on Transfer Pricing, which represents the industry on dialogues with
