The 2nd Taylor's International Conference on the Future of Law and Legal Practice (ICFLP 2021), to be organized by Taylor's Law School in Taylor's University on 26 and 27 October 2021, in a fully online e-Conference format, aims to explore contemporary legal developments in Malaysia and abroad. The theme of ICFLP 2021 is '**Law and Legal Practice in the Post-Pandemic Era: Opportunities, Solutions and Innovations**'.

ICFLP 2021 aims to canvass the unique nature of the challenges posed to law, legal practice, and the teaching and learning of law by a global pandemic such as COVID-19; the ingenuity of the legal and regulatory responses around the world; and the opportunities for the development of law, legal practice, and legal pedagogy in the post-pandemic era.

The International Conference aims to showcase a range of academic and practice-oriented perspectives on these issues, exploring the ways in which the practice and teaching of law - and indeed the fundamental concept of law itself - can be developed in response to the challenges created by a global pandemic such as COVID-19 with the assistance of technology and innovation driven solutions.

Participants from academia, legal practice, and related industries have been invited to present papers and to share their thoughts and views relating to various aspect of these broad themes. Presentations at the International Conference will be clustered into four main streams, namely Private Law, Healthcare & Medical Law, Public Law, and Legal Education.

The International Conference is intended to provide a forum for scholars, practitioners, regulators, academics, and researchers to explore and debate issues relating to the innovations and opportunities highlighted by the COVID-19 pandemic. Junior scholars and those seeking to develop ideas towards publication are particularly encouraged to present.

Private Law
